Title: Supplying, installation, testing and commissioning of 3 closed greenhouses with hydroponics & aquaponics installation, 14 open greenhouses and 40 ha open field irrigation systems (goods)

In the framework of project RWA/030 receiving financial support from the governments of the Grand Duchy of Luxembourg and Rwanda

This notice of invitation is launched by and according to the procedures of LuxDev, Luxembourg Development Cooperation Agency, on behalf of project RWA/030 receiving financial support from the governments of Rwanda and of the Grand Duchy of Luxembourg.
