



NOTICE OF INVITATION TO TENDER N° KSV/023 • 25 7989

**Title: Cybersecurity lab equipment supply, installation and training
within the cybersecurity agency (goods)**

*In the framework of project KSV/023 receiving financial support from the government
of the Grand Duchy of Luxembourg*

This notice of invitation is launched by and according to the procedures of LuxDev, the Luxembourg Development Cooperation Agency, on behalf of project KSV/023 receiving financial support from the government of the Grand Duchy of Luxembourg.

1. IDENTIFICATION AND FINANCING OF THE PROJECT/PROGRAMME

- a) Title: KSV/023 – Sustainable and inclusive growth in Kosovo
- b) Source of financing: The government of the Grand Duchy of Luxembourg as set out in the project's bilateral agreement dated 12.10.2023
- c) Status of financing: Approved

2. IDENTIFICATION OF THE CONTRACT

- a) Type of contract: Goods
- b) Object: Cybersecurity lab equipment supply, installation and training within the cybersecurity agency

3. ELIGIBILITY AND EVALUATION CRITERIA

- a) Origin: Companies must satisfy the Rules of Origin criteria: Applications that involve equipment manufacturers from the Prohibited Countries' PCR origin as well as equipment from countries and companiesⁱⁱ which are on the Kosovo Public Procurement Regulatory Commission's sanction list, will not be eligible." The rule of origin is based on the Notice to Contracting Parties issued by Kosovo Public Procurement Regulatory Commission, as well as the following three important documents/decisions:

1. List of Equipment and Services Covered By Section 2 of The Secure Networks Act (List of Equipment and Services Covered By Section 2 of The Secure Networks Act) Federal Communications Commission;

2. Government of the Republic of Kosovo Decision No. 01/64 dated 25.02.2022 with it amendment and supplement dated 10.05.2023,

3. Government of the Republic of Kosovo Decision No. 01/78 dated 16.05.2022.

- b) Eligibility: Equipment to be assembled in the EU, US, or Canada;
- c) Eligibility: Economic operators satisfying the criteria included in the statement of good standing and in the ethics clauses of the general regulations - **please be aware that companies which are not registered in Kosovo may need a local grouping member in order to execute the import or have to**



register in Kosovo. Project KSV/023 will not be able to support the registration in Kosovo and can in no way be held accountable for delays in the registration process.

- d) Evaluation: The most economically advantageous tender on the basis of price will be granted the contract.
- e) Variants: No variants will be considered

4. LOCATION AND TIMEFRAME

- a) Location of the project: Prishtina, Kosovo
- b) Terms and place of delivery: DDP delivered and installed in Prishtina (Kosovo) at the Cybersecurity agency (CSA), under the Ministry of Internal Affairs (MIA). The delivery and installation shall take place at CSA, provided the CSA is ready at the time of delivery. In the event that the Cyber Security Agency (CSA) is not ready at the time of delivery (primary location), the supplier shall, deliver and install the goods at an interim location designated by the contracting authority and the beneficiary, in this case the Ministry of Internal Affairs. This location will be in one of the buildings of the Ministry of Internal Affairs of the Republic of Kosovo. Once CSA is ready, the supplier shall relocate and reinstall the goods at CSA at the price grantees for the reinstallation in the bill of price. The final re-installation will only occur once the CSA is deemed ready but not later than 31.10.2026.
- c) Performance period of the contract: 5 months for the supply, installation and training.
- d) Maintenance and support: during the warranty period of at least 3 years, starting from the signing of the takeover minutes, regardless of whether the goods are first installed at the primary or the interim location. Re-installment of the goods shall be performed when the agency is ready but no latter until 31.10.2026. By and between the contract award, the contractor must adhere to remain responsible for any storage costs incurred as imposed by the suspensive clause, until the suspensive clause is waived accordingly.
- e) Validity period of tenders: 120 days from the time limit for receipt of tenders.
