The contracting authority reserves the right to award lots or groups of lots that can be combined to be awarded to the same tenderer, if they are more technically and economically advantageous for the project.  
  
A single or several lots may be awarded to the same company, if the company cumulatively meets the evaluation criteria, i.e. the administrative and technical criteria.
