- b) Eligibility: Economic operators satisfying the criteria included in the statement of good standing and in the ethics clauses of the general regulations.
- c) Evaluation: The award will be made lot by lot to the lowest administratively and substantially technically compliant tender, but according to the most advantageous combination for the programme.
 - A single or two lots may be awarded to the same company, if the company cumulatively meets the evaluation criteria, i.e. the administrative and technical criteria.
