IDENTIFICATION AND FINANCING OF THE PROJECT/PROGRAMME

- a) Title: Local Development Programme LAO/338
- b) Source of financing: the Lao PDR, the Grand Duchy of Luxembourg and the Swiss Confederation as set out in the programme's bilateral agreement dated 05.12.2022
- c) Status of financing: Approved

2. IDENTIFICATION OF THE CONTRACT

a) Type of contract: Goods

b) Object: Procurement of outdoor playground equipment for 225 target schools in

Vientiane, Bolikhamxay, Bokeo and Khammouan Province.

d) Number of lots: 4

Lot 1: Vientiane Province - 6 districts, 52 villages

Lot 2: Bolikhamxay Province - 4 districts, 56 villages

Lot 3: Bokeo Province - 3 districts, 53 villages

Lot 4: Khammouan Province - 4 districts, 64 villages

e) Grouping of lots: Tenderers may apply for one or more lots. A tenderer may submit an offer for multiple lots and may be awarded one or more lots. However, to be awarded several lots, the tenderer must cumulatively meet the evaluation criteria for all the lots concerned.

3. ELIGIBILITY AND EVALUATION CRITERIA

- a) Origin: No restriction
- b) Eligibility: Economic operators satisfying the criteria included in the statement of good standing and in the ethics clauses of the general regulations.
- c) Evaluation: The most economically advantageous tender on the basis of price will be granted the contract (lot by lot).
- d) Variants: No variants will be considered

4. LOCATION AND TIMEFRAME

- a) Location of the programme: Vientiane Capital, Lao PDR
- b) Terms and place of delivery: DDP to Vientiane, Bolikhamxay, Bokeo and Khammouan Province
- c) Performance period of the contract: 10 months
