Title: Technical Assistance for the Adequacy and Reinforcement of the Building Legal Framework in Cabo Verde

Maximum budget: 150 000 EUR - Performance period of 7 months

The Luxembourg Agency for development Cooperation (LuxDev) launches a Call for expression of interest for the acquisition of services for **Technical assistance** for **the Adequacy and Reinforcement of the Building Legal Framework in Cabo Verde** on behalf of programme CVE/390 receiving financial support from the governments of the Republic of Cabo Verde and the Grand-Duchy of Luxembourg.

Services providers that are invited to express their interest to offer the services mentioned above are all legally established companies governed by private law (excluding non-governmental organisations, not-for-profit organisations and public operators) and specialised in areas of Building Code Development, Legal Affairs in the Construction Sector or Energy Efficiency in Buildings.

Indicatively, service providers must demonstrate their technical capacity and experience in work to support governance in the development of the legal framework for the building and urban planning sector.

The working language is Portuguese and all products must be delivered in Portuguese.

The start of the contract is foreseen for March 2023 with a duration of 7 months. Services providers must be available for the entire period foreseen and willing to intervene in the islands of Santiago, São Vicente, and Sal. The maximum budget available for this contract is estimated at 150 000 EUR (all taxes excluded).

Interested services providers are invited to submit sufficient documentation to respond to the selection criteria. The dossier, including the selection criteria and the application form, is available on request at the address given below.
