Title: Installation of HVAC systems, vinyl floor and RO & RO-EDI water system at Maria Teresa Hospital (goods)

In the framework of programme LAO/035 receiving financial support from the governments of the Grand Duchy of Luxembourg and the LAO PDR

This notice of invitation is launched by and according to the procedures of LuxDev, the Luxembourg Development Cooperation Agency, on behalf of programme LAO/035 receiving financial support from the governments of the Lao PDR and of the Grand Duchy of Luxembourg.

1. IDENTIFICATION AND FINANCING OF THE PROJECT/PROGRAMME

- e) Grouping of lots: Tenderers may apply for one or more lots. A tenderer may submit an offer for multiple lots and may be awarded one or more lots. However, to be awarded several lots, the tenderer must cumulatively meet the evaluation criteria for all the lots concerned.

- b) Eligibility: Economic operators satisfying the criteria included in the statement of good standing and in the ethics clauses of the general regulations.
- c) Evaluation: The most economically advantageous tender on the basis of price will be granted the contract (lot by lot).
